the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Dorothy N. Schipper, her heirs and assigns forever a Five Thousand (\$5,000.00) equity in the following described property:

"ALL that certain piece, parcel or lot of land lying and being situate in the State of South Carolina, County of Greenville, in Cleveland Township, on the South side of Caesar's Head Drive, and having the following metes and bounds, to-wit:

BEGINNING at a stake on the South side of Caesar's Head Drive, corner of lot No. Sixty Six (66), formerly deeded to W. W. Ball, running thence with the line of lot No. Sixty Six (66) South 15-40 West One Hundred Twenty (120) feet to a stake; thence South 74-20 East One Hundred (100) feet to a stake; thence North 15-40 East One Hundred Twenty (120) feet to a stake on the South side of Caesar's Head Drive; thence with said drive North 74-20 West One Hundred (100) feet to the beginning corner, and being lots Sixty-Six -A (66-A) Section A Development Caesar's Head; being the same lot conveyed to Lidie H. Shanklin by Paris Mountain-Caesar's Head Company by deed dated September 12, 1927, and recorded in Book of Deeds 132, at page 57; being the same lot conveyed to Gertrude H. Matthews by Lidie H. Shanklin by deed dated December 4, 1936, and recorded in Book of Deeds 191, at page 223; and being the identical lot conveyed to Julien D. Wyatt by Gertrude H. Matthews by deed dated June 16, 1947, and recorded in Book of Deed 314, at page 392; being the same lot conveyed to Edgar M. Norris by Julien D. Wyatt by deed dated January 21, 1948, and recorded in Book of Deeds 334, at page 47 in the office of the Register of Mesne Conveyance for Greenville County, South Carolina.

This deed is made subject to the restrictions contained in the deed of Paris Mt.-Caesar's Head Company to Lidie H. Shanklin mentioned above.
