the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Bobby G. Davis, Sr., and Linda B. Davis, their heirs and assigns forever:

ALL that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in Greenville County, South Carolina, on the Southern side of Woodville Road between Pelzer and Woodville, and containing 0.39 acres, more or less, and having the following metes and bounds according to a plat thereof entitled "Property of James E. Davis" prepared by C. O. Riddle, R.L.S., dated December 16, 1977, and recorded in the R.M.C. Office for Greenville County in Plat Book 6-L at page 22:

BEGINNING at a point on the center line of Woodville Road at the Northeastern-most corner of other property of the grantees herein and running thence with the Eastern line of the property of the grantees herein, S. 8-25 W., 276.9 feet to an iron pin; thence with the Southern line of other property of the grantees herein, N. 81-35 W., 245 feet to an old iron pin; thence S. 54-07 E., 137.1 feet to an iron pin; thence N. 80-05 E., 179.4 feet to an iron pin; thence N.0-08 E., 286.8 feet through an iron pin on the Southern side of Woodville Road to a spike in the center line of Woodville Road; thence with the center line of Woodville Road, N. 81-35 W., 5.3 feet to the point of beginning.
