the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell  
and release unto MILTON TROTTER, his heirs and assigns forever:

ALL my right, title and interest, the same being an undivided one-seventh (1/7) interest, in and to the following described real estate:

ALL that piece, parcel or lot of land, being shown as Tract No. 1, consisting of 45.674 acres on a plat entitled "Lucy S. Terry Estate", dated January 3, 1977, by Morgan & Applewhite Engineering Associates, Anderson, South Carolina, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a new iron pin at or near the center of Terry Road, and running thence along the joint line with property designated "Lewis C. Terry Property", S. 89-31 E. 1518.0 feet to a new iron pin at an old stone corner; thence S. 28-33 W. 188.8 feet; thence S. 45-43 E. 150.1 feet to a point in the center of a creek; thence S. 62-17 W. 17.7 feet to a new iron pin; thence S. 62-17 W. 201.9 feet to a new iron pin; thence S. 4-47 W. 393.4 feet; thence S. 4-47 W. 499 feet to a new iron pin at an old stone corner; thence S. 7-50 W. 210.6 feet to a new iron pin at an old stone corner; thence N. 82-53 W. 1438.3 feet to an old iron pin at or near the center of Terry Road; thence with the center line of Terry Road, as follows: N. 4-38 E. 194.6 feet to a nail; N. 8-07 E. 200 feet to a nail; N. 22-06 E. 150 feet to a nail; N. 26-33 E. 150 feet to a nail; N. 6-07 E. 100 feet to a nail; N. 5-52 W. 100 feet to a nail; N. 12-59 W. 100 feet to a nail; N. 2-05 E. 100 feet to a nail; N. 9-26 E. 100 feet to a nail at the fork of Terry Road with another road; thence continuing with the center of Terry Road, N. 9-26 E. 147.6 feet to the point of beginning.
