Mann, and running thence with the Babb line, S. 22-04 W. 186.66 feet to a point on the edge of Sullivan Street; thence running with said Street, N. 0-02 W. 119.55 feet to a point on the edge of said Street; thence running with the curvature of said Street, the chord being: N. 11-36 E. 35.2 feet and N. 41-16 E. 43.7 feet; thence continuing with said Street, S. 67-56 E. 37 feet to an iron pin on the edge of said Street, the point of Beginning.
