ALL that certain piece, parcel or lot of land situate in Dunklin Township, Greenville County, State of South Carolina, containing fourteen and five-tenths (14.5) acres, more or less, as shown on plat made by James L. Strickland, Reg. L. S., dated January 2, 1978, of record in the RMC Office for Greenville County in Plat Book 6.8 at page 86, having the following metes and bounds:

BEGINNING at an iron pin in the middle of Pinson Road, thence along Pinson Road N22-37W 446 feet to iron pin; thence N72-22E 1156.8 feet to iron pin; thence S36-41E 877.1 feet to iron pin, thence S59-15W 340 feet to iron pin; thence N38-00W 641.1 feet to iron pin; thence S63-06W 861.8 feet to beginning point; said lot being bounded by Pinson Road, lands of Truman A.
