All that certain piece, parcel or lot of land, situate, lying and being on the western side of Pine Ridge Drive in Gantt Township, near the City of Greenville County of Greenville, State of South Carolina, being shown as Lot No. 10 of Section 2 on a plat of Fresh Meadow Farms, made by H. H. Woodward, R. E., May 21, 1945, recorded in Plat Book "S" at Page 61 in the R. M. S. Office for Greenville County, South Carolina, and having, according to said plat, the following notes and bounds, to-wit:

BEGINNING at an iron pin located on the West side of Pine Ridge Drive being the joint front corner of Lots 9 and 10, and running thence along the West side of Pine Ridge Drive, S. 16-47 W. 47 feet to an iron pin; thence running S. 19-47 E. 43 feet along the West side of Pine Ridge Drive to an iron pin, being the joint front corner of Lots 10 and 11; thence running S. 73-15 W. 215.7 feet to an iron pin located on the rear line of Lot 37, being the joint rear corner of Lots 10 and 11; thence running N. 24-05 W. 49.7 feet to an iron pin located on the rear line of Lot 36; thence N. 24-05 W. 35.3 feet to an iron pin located at the joint rear corner of Lots 9 and 10; thence running N. 73-15 E. 225.4 feet to an iron pin located on the West side of Pine Ridge Drive, being the joint front corner of Lots 9 and 10, the point of beginning.
