All that certain piece, parcel or tract of land in Greenville County, State of South Carolina, also partially in Laurens County, State of South Carolina, being known and designated as Lot No. 5 on plat of property of BENTTREE RANCHETTES, formerly Bonds property, prepared by J. L. Montgomery, III., dated April, 1973, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a point in the center of County Road, which point is located S. 62-58 E., 20 feet from iron pin on the Westerly edge of said road at the joint front corner of Lots Nos. 5 and 6, and running thence with the joint line of said lots N. 62-58 W., 1076.8 feet to an iron pin at the joint rear corner of said lots in line of property now or formerly of Jones; thence with the line of said Jones property N. 8-49 E., 145.0 feet to an iron pin; thence N. 17-28 E., 123.1 feet to an iron pin at the joint rear corner of Lots 4 and 5; thence with the joint line of said lots S. 68-19 E., 1082.0 feet to a point in center of County Road, passing over iron pin 20 feet back on line; thence with the center line of County Road S. 18-10 W., 74.6 feet to a point; thence continuing with the center line of said County Road, S. 16-24 W., 291.2 feet to the beginning corner.
