the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Carl S. Chapman, his heirs and assigns forever, All my right, title and interest, the  
same being an undivided one-third (1/3) interest, in and to the following described property:

All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, located at the intersection of Green Avenue and McLeod Avenue being known and designated as Lot No. 1 according to plat of property of F. B. Bozeman, et al prepared by Jones Engineering Service, RLS, dated January 3, 1977 and recorded in the RMC Office for Greenville County in Plat Book 6A at Page 21 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the intersection of the southwestern side of Green Avenue with the southeastern side of McLeod Avenue and running thence with Green Avenue S. 19-57 E. 100.5 feet to an iron pin, joint front corner of Lots 1 and 2 and thence with the joint line of said lots S. 58-19 W. 216.2 feet to an iron pin; thence N. 23-00 W. 77.4 feet to an iron pin on the southeastern side of McLeod Avenue; thence with McLeod Avenue N. 52-46 E. 226 feet to the point of BEGINNING. 95-4-1.1 (NOTE)

This being a portion of the same property conveyed to A. N. Bozeman by deed dated August 6, 1902 and recorded in the RMC Office for Greenville County in Deed Book iii at Page 799. The said A. N. Bozeman died intestate in 1931, as more fully appears in the Probate Court filed in the Office of Probate Judge in Apartment 275 at File 19, leaving the property to his widow and three children. His widow Mary L. Bozeman died testate in 1965 willing her one-third interest to her three children as trustees. This more fully appears in the Probate Court filed in the Office of Probate Judge in Apartment 929 at File 2. The Grantor herein together with his Brother, A. N. Bozeman, and his Sister, Helen B. Ferguson is conveying the entire property to the Grantee herein in fee simple.
