McAlister, prepared by Pickell and Pickell, Engineers, dated October 16, 1948, and revised on February 24, 1949, and recorded in Plat Book EE at page 92 in the RMC Office for Greenville County, and also being shown on a plat of the property of William Ralph Batson Estate, dated March 25, 1976, and recorded in Plat Book 6-A at page 53 in the RMC Office for Greenville County, and having according to said latter plat the following metes and bounds, to-wit:

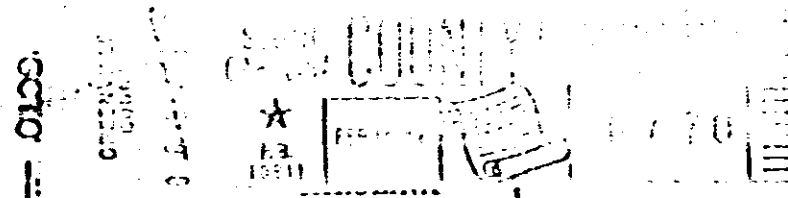
