Parker Estate, prepared by Gould & Assoc., Surveyors, and having, according to said plat, the following metes and bounds to wit:

BEGINNING at an iron pin on the Southeasterly edge of thirty foot easement reserved for road (private) and running thence along property to be conveyed to Daniel Dean and Louise K.
