Freeman, hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northern side of Stanley Drive, near the City of Greenville, being shown as Unit 83 on plat of Harbor Town, recorded in the R.M.C. Office for Greenville County in Plat Book 5P, at Pages 13 and 14, and being more particularly described as follows:

BEGINNING at a point at the joint corner of Units 83 and 82 and thence running N 39-10 E 21.4 feet; thence turning and running S 50-50 E 73 feet; thence turning and running S 39-10 W 21.4 feet; thence turning and running N 50-50 W 73 feet to the point of Beginning. - 305 - B 2.4 - 1 - 83
