Know All Men by These Presents:

That Harbor Town Limited Partnership, A S. C. Limited Partnership, hereafter referred to as Grantor, in consideration of the sum of Two Thousand Five Hundred and No/100 (\$2500.00) & Assumption of Mortgage as set forth below by Robert N. Titcomb, hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, his heirs and assigns forever:

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northern side of Stanley Drive, near the City of Greenville, being shown as Unit 54 on plat of Harbor Town, recorded in the RMC Office for Greenville County in Plat Book 5P, at Pages 13 and 14, and being more particularly described as follows:

BEGINNING at a point at the corner of Units 54 and 55 and thence running S 50-25 E 68 feet; thence turning and running S 39-35 W 20.7 feet; thence turning and running N 50-25 W 68 feet; thence turning and running N 39-35 E 20.7 feet to the point of Beginning.

The foregoing conveyance is subject to the terms of that Declaration of Covenants, Conditions and Restrictions, executed by Harbor Town Limited Partnership on January 26, 1976, in Deed Book 1031, at Page 271.

This is the same Property conveyed to the grantor by James C. Bible III & Patricia C. Bible by deed dated 6/2/77 and recorded 6/8/77, in the R.M.C. Office for Greenville County, South Carolina in Deed Book 1058 at Page 180.

This conveyance is made subject to that certain mortgage granted by James C. Bible, III, and Patricia C. Bible to Mid-South Mortgage Company, Inc. dated February 7, 1977 and recorded in the Office of the R.M.C. for Greenville County, South Carolina, in Mortgage Book 1388, at Page 782; said mortgage having been subsequently assigned to Walt Whitman Federal Savings & Loan Association by Assignment dated February 7, 1977, and recorded February 8, 1977, in Mortgage Book 1388, at Page 786. Said mortgage having a principal balance of Thirty-one Thousand Five Hundred Eighty-one and 23/100 Dollars (\$31,581.23). Grantee hereby assumes and agrees to pay the note secured by said mortgage.
