Office for Greenville County, and having according to a more recent survey by R. W. Dalton, dated June, 1953, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northwestern side of Princeton Avenue at the joint front corner of Lots Nos. 30 and 31, and running thence with the line of Lot No. 30, N. 33-10 W. 150 feet to an iron pin; thence S. 56-50 W. 75 feet to an iron pin at the joint rear corner of Lots Nos. 31 and 32; thence with the line of Lot No. 32, S. 33-10 E. 150 feet to an iron pin at the joint front corner of Lots Nos. 31 and 32 on the northwestern side of Princeton Avenue; thence with the northwestern side of Princeton Avenue, N. 50-56 E. 75 feet to an iron pin, the beginning corner.

This conveyance is subject to any and all existing reservations, easements, rights of ways, zoning ordinances and restrictions or protective covenants that may appear of record, on the recorded plat(s) or on the premises.
