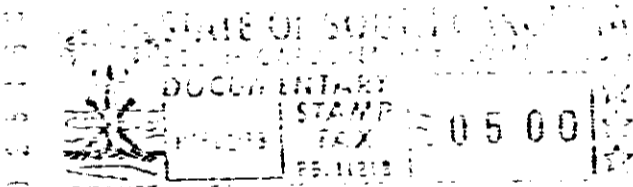
All of our undivided three-fourths (3/4) interest in and to the following real property:
