BEGINNING at an iron pin on the Southern end of Halloway Circle on a cul-de-sac at the joint front corner of Lots Nos. 31 and 42 (Lot No. 42 has heretofore been sold according to description in Plat Book XX, Page 173); thence with the common line of said lot, S. 1-0 W., 170 feet to an iron pin; thence S. 76-33 W., 103 feet to an iron pin at the joint rear corner of Lots Nos. 31 and 25; thence with the joint line of said lots, N. 32-24 W., 151.9 feet to an iron pin at the joint rear corner of Lots Nos. 31, 30 and 25; thence with the joint rear corner of Lots Nos. 25 and 30, N. 32-24 W., 110 feet to an iron pin at the joint rear corner of Lots Nos. 25, 29 and 30; thence N. 49-51 E., 160 feet to an iron pin on the Western side of Halloway Circle; thence along said Circle, S. 45-18 E., 105.5 feet to an iron pin; thence continuing along said Circle, S. 5-09 E., 18 feet to an iron pin at the joint front corner of Lots Nos. 30 and 31; thence along the cul-de-sac of said Circle, the chord of which is S. 51-03 E., 60 feet to an iron pin, the beginning corner.
