(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents

do grant, bargain, sell and release unto the said COTHRAN & DARBY BUILDERS, INC., its successors and assigns forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southeasterly side of Sun Meadow Road, near the City of Greenville, S. C., being known and designated as Lot No. 122 on plat entitled Map No. 5, Sugar Creek, as recorded in the RMC Office for Greenville County, S. C., in Plat Book 6H, page 2 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Sun Meadow Road said pin being the joint front corner of Lots 121 and 122 and running thence with the common line of said lots S 50-52-22 E 172.91 feet to an iron pin, the joint rear corner of Lots 121 and 122; thence N 38-36-18 E 125 feet to an iron pin, the joint rear corner of Lots 122 and 123; thence with the common line of said lots N 50-52-22 W 171.77 feet to an iron pin on the southeasterly side of Sun Meadow Road; thence with the southeasterly side of Sun Meadow Road S 39-07-30 W 124.99 feet to an iron pin, the point of beginning.
