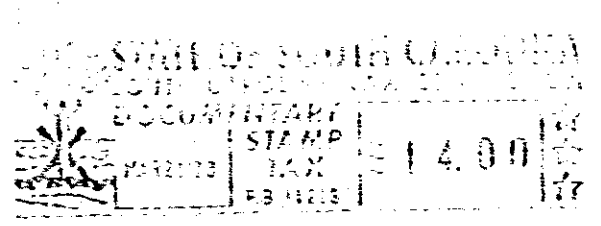
KNOW ALL MEN BY THESE PRESENTS, that **OAK, INC.**
