All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as 4.41 acres on a plat of property of Mrs. Janis F. Gilmore, prepared by Freeland & Associates, dated April 13, 1978, and being recorded in the R.M.C. Office for Greenville County in Plat Book 6-0, Page 62, said property lying on the southern side of Devenger Road and having, according to said plat, the following metes and bounds, to-wit:
