KNOW ALL MEN BY THESE PRESENTS, that W. P. GREGORY and PAULINE R. GREGORY

in consideration of SEVEN THOUSAND AND NO/100 (\$7,000.00) Dollars

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto J. BRUCE KING, II, his heirs and assigns forever:

ALL that piece, parcel or tract of land containing 4 acres, more or less, situate, lying and being on the eastern side of a county road known as Settlement Road, near Travelers Rest, Greenville County, South Carolina, being shown as the easternmost portion of Tract No. 4 on a division of the property of James R. Gregory made by Campbell & Clarkson, Surveyors, dated August 15, 1966, recorded in the RMC Office for Greenville County, South Carolina in Plat Book 000 at page 57, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point in or near the center line of Settlement Road, at the corner of tracts 3 and 4; and running thence S. 58-13 E., 509.7 feet to an iron pin; thence N. 38-45 E., 200 feet to an iron pin at the joint corners of tracts 3 and 4; thence along the line of property of the grantee, and running through the Old Settlement Road, N. 51-15 W., 848 feet to an iron pin in the center line of Settlement Road; thence a new line through tract 4, and following the center line of Settlement Road approximately S. 8-00 E., 225 feet to an iron pin in said road at the joint corner of tracts 4 and 5; thence with the common line of said tracts and continuing with the center line of Settlement Road, S. 8-40 E., 180 feet to the point of BEGINNING.

The above described property is the same conveyed to the W. P. Gregory by deed of James R. Gregory recorded in Deed Book 805, page 336, on September 6, 1966, and a one-half interest in which was conveyed to Pauline R. Gregory by deed of W. P. Gregory recorded in Deed Book 1059, page 532 on June 29, 1977, and is hereby conveyed subject to rights of way, easements, conditions, roadways, setback lines and restrictive covenants reserved on plats and other instruments of public record and actually existing on the ground affecting said property.

The grantee herein agrees to pay Greenville County property taxes for the tax year 1978 and subsequent years.
