KNOW ALL MEN BY THESE PRESENTS, that we, Kathryn W. Hill, Connie W. Nelson, Mary W. Langley, Rownie W. Caldwell and Emily W. Southern

in consideration of Three Thousand One Hundred Eighty-One and 82/100 (\$3,181.82)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Smiley R. Wilbanks and Joyce A. Wilbanks, their heirs and assigns, forever, all of our interest of, in and to the following described property:

All that piece, parcel or lot of land, situate, lying and being on the northern side of Camp Creek Road, near the City of Greenville, in the County of Greenville, State of South Carolina, and known as an .82 acre tract of the Property of S. G. Wilbanks by plat prepared by Wolfe & Huskey, Inc., dated December, 1975, and according to said plat, has the following metes and bounds, to wit:

BEGINNING at an iron pin on the northern side of Camp Creek Road, which iron pin is 150 feet southeast from the joint corner of a 14.55 acre tract on said plat, and property now or formerly of T. A. Lynn, and running thence along a new line, N. 35-06 E., 208 feet to an iron pin; running thence S. 62-15 E., 142 feet to an iron pin; running thence S. 20-32 W., 262 feet to an iron pin on the northern side of Camp Creek Road, which iron pin is 150.3 feet northwest of the joint corner of the 14.55 acre tract and property now or formerly of Clinton Babb; running thence with the northern side of Camp Creek Road, N. 59-59 W., 197 feet to an iron pin, point of beginning. ALSO: All that piece, parcel or lot of land situate, lying and being at the northern and eastern edge of a 14.55 acre tract as shown on the plat above referred to and is shown on the Greenville County Block Books as Lot 7, Block 1, page 635.4. It is the intention of the Grantors herein to convey all of the remainder of the property owned by the Estate of Pearl Smith Wilbanks and acquired as hereinbelow set forth.

This is a portion of the property conveyed to S. G. Wilbanks by Lora M. Davis, Joseph E. Davis and Sarah D. Bishop, by deed dated March 31, 1947, and recorded in the RMC Office for Greenville County in Deed Book 310, at page 73, the said S. G. Wilbanks died testate on or about the 10th day of January, 1977, leaving the said property to his widow, Pearl Smith Wilbanks, as will more fully appear by examination of the Probate records of Greenville County, Apartment 1456, file 23. The said Pearl Smith Wilbanks died intestate on or about the 8th day of June, 1977, leaving the Grantors herein and the Grantee herein, and Bobbie W. Tucker, Marcelle W. Lynn, Lecil D. Wilbanks, Louise W. Few and Brenda W. Collins as her sole heirs at law, as will more fully appear from examination of Probate Apartment 1476, file 15. This property is conveyed subject to easements, conditions, covenants,

restrictions and rights of way which are a matter of record and actually existing on the ground effecting the subject property. -315-235.4-1-7, 7.3 (NOTE) together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining, to have and to hold all and singular the premises before mentioned unto the grantee(s) and the grantee(s)'s heirs, successors and assigns forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs, successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs, successors and assigns against the grantor(s) and the grantor(s)'s heirs, successors and assigns and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
