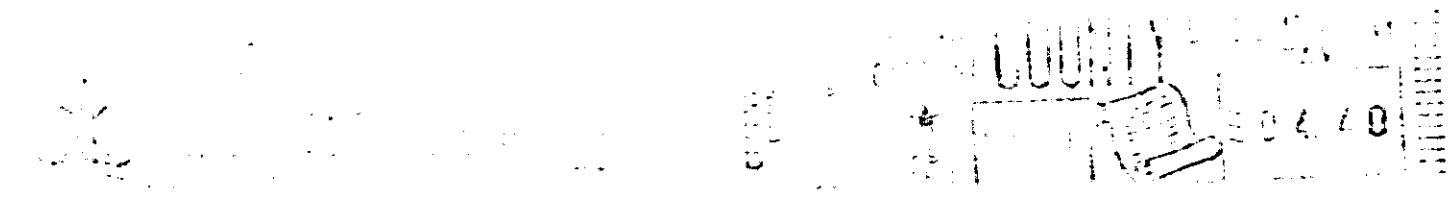
KNOW ALL MEN BY THESE PRESENTS, that Douglas M. Raines and Marcia C. Raines,
