CHARLES H. BRACKEN, His Heirs and Assigns, Forever:

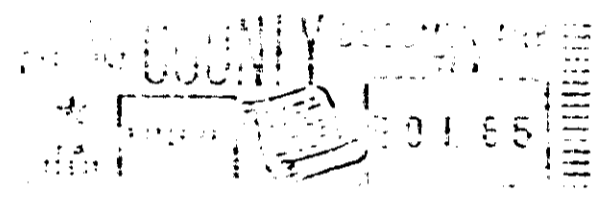
