QUITCLAIM

KNOWN ALL MEN BY THESE PRESENTS, that John F. Chandler

in consideration of One Dollar and no/100's-----(\$1.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto The City of Greenville, a municipal corporation, P. O. Box 2207, Greenville, South Carolina, 29602, its successors and assigns:

ALL of my undivided interest that I may have in and to that one foot strip along the southwestern side of Beattie Place between the sidewalk and the property lines and having the following metes and bounds to wit:

BEGINNING at an iron pin on the southeastern side of North Brown Street at the northwestern corner of a tract of land now or formerly owned by the grantor herein, and shown on a plat prepared by C. O. Riddle, Surveyor, dated January 3, 1959, entitled "Property of John D. Pellett, Jr., et al," and recorded in the RMC Office in Plat Book SS at page 89, and running thence with the line of said tract S. 59-15 E. 125.8 feet, more or less, to an iron pin; thence continuing with said tract S. 58-58 E. 42.7 feet, more or less, to an iron pin; thence still continuing with said tract S. 55-29 E. 42.7 feet, more or less, to an iron pin; thence in a northeasterly direction one foot, more or less, to the southwestern edge of the sidewalk which runs along the southwestern side of Beattie Place; thence with the southwestern edge of said sidewalk in a northwesterly direction 212 feet, more or less, to a point where the said sidewalk intersects with the sidewalk which runs along the southeastern side of North Brown Street; thence in a southwesterly direction one foot, more or less, to the point of beginning.

THE intention of this deed being that the grantor wishes to convey to the grantee any right, title or interest that he may have in the property which the City of Greenville conveyed to the grantor by deed recorded in the RMC office in Deed Volume 620 page 476 on April 3, 1959 at 2:35.
