the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto The City of Greenville, a municipal corporation, P.O. Box 2207, Greenville, South Carolina 29602.

All that piece, parcel or lot of land lying and being in the City of Greenville, County, and State aforesaid and lying on the southern side of Birnie Street and being known and designated as the southern part of lot number 4, according to plat recorded in the RMC office in plat book E page 125 entitled "Property of H.W. Hunt" and having the following metes and bounds to wit:

Beginning at a point 54.7 feet more or less south of Birnie Street and being approximately 78.25 feet more or less from Burns Alley and running thence N. 60 W. 28.5 feet more or less to a point on lot no. 5; thence running with lot 5 N. 30-19 E. 60 feet more or less to a point on the line of lot No. 11; thence S. 60-00 E. 28.5 feet more or less to a point; thence running along the line of lot no. 7 S. 30-19 W. 60 feet, more or less, to the beginning corner.

This property is known and designated as Block Book <sup>500 -</sup> 76.3-6-9.
