(Name of Place) East Stone Ave. (Name of Place) Spartanburg Street State and County aforesaid, as shown by plans prepared by the City of Greenville on and over all land which I (or we) own and are furtherdescribed below, for the purpose of locating, constructing improving, and maintaining the above described highway with the bridges and causeways thereon, and the right to construct and maintain controlled access facilities to said highway:

DERIVATION: Vol. 966, page 192, recorded Jan 31, 1973 from I. L. Donkle Company Said property is described as follows: ALL that parcel designated as Lot 53 on a plat of F. F. Beattie property recorded in the RMC Office for Greenville County in Plat Book C, Page 236 and beginning at a point on Old Spartanburg Street at the joint corner of Lots 54 and 53 and running thence with the joint line of said lots N. 41-30 W. 100 feet, more or less, to the joint near corner of said lots; thence running S. 50-45 W. 40 feet, more or less, to a point; thence S. 41-30 E. 100 feet, more or less, to Sparanburg Street; thence 40 feet, more or less, N. 50-45 E. to the beginning.
