ALL that piece, parcel or lot of land lying, being and situate in the County of Greenville, State of South Carolina, being shown and designated as Lot 28 on a plat of Eastdale Development, said plat being recorded in Plat Book YY, Pages 118 and 119 in the RMC Office for Greenville County, and being more particularly described in accordance with a more recent plat entitled "Property of Trevor L. and Becki W. Price" dated July 1, 1978, prepared by T. H. Walker, Jr., RLS, to-wit:
