release unto W. N. Leslie, Inc., its successors and assigns forever:

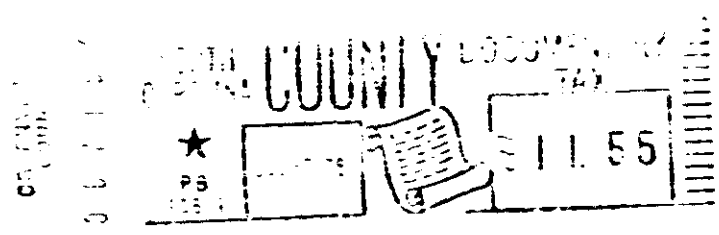
ALL that certain piece, parcel or lot of land located, lying and being in the County of
