sell and release unto Cloyd A. Bookout and Martha W. Bookout, their heirs and assigns, forever:

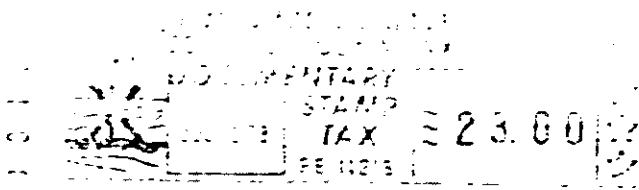
All that piece, parcel or lot of land lying in the State of South Carolina, County of
