and release unto SANDRA THOMPSON, her heirs and assigns, forever:

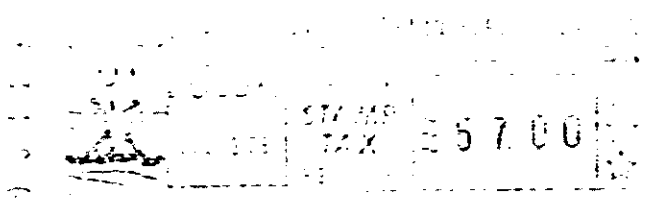
All that piece, parcel or lot of land situate, lying and being in Gantt Township,
