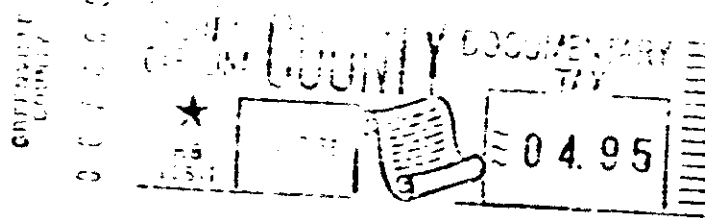
WOODROW HARMON, his heirs and assigns forever:
