in consideration of Twenty-Eight Thousand Nine Hundred and No/100-----(\$28,900.00)-----Dollars,

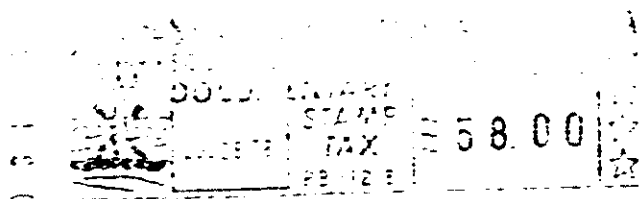
