5-D at Page 98 and having, according to said plat, the following metes and bounds, to-wit:

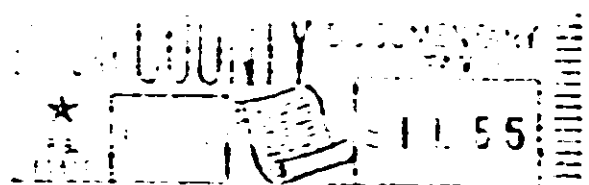
BEGINNING at a point on the eastern side of Brandywine Court at the joint front corner
