the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Edward D. Massengale and Jennie A. Massengale, their heirs and assigns forever, all rights, title and interest in and to:

ALL that certain piece, parcel or lot of land on the West side of Whitney Street, in the Village of S. Slater & Sons, Inc., at Slater, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 11 of Block C, as shown on a plat of the Village of S. Slater & Sons, Inc., made by J.E. Sirrine & Company, Engineers, on July 10, 1940, which plat is recorded in the R.M.C. Office for Greenville County, in Plat Book K, at pages 63, 64, and 65 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Whitney Street (formerly Hoover Street), joint front corner of Lots No. 10 and 11, and running thence with the line of Lot no. 10, N. 57-30 W. 125 feet to an iron pin in the rear line of Lot No. 26; thence with the rear lines of Lots No. 25 and 26, N. 32-30 E. 70 feet to an iron pin in the rear line of Lot 25, joint rear corner of Lots No. 11 and 12; thence with the line of Lot No. 12, S. 57-30 E. 125 feet to an iron pin on the West side of Whitney Street; thence with the West side of Whitney Street, S. 32-30 W. 70 feet to the beginning corner.

This being the same property conveyed to Charles E. Dodson and Lizzie B. Dodson by deed of S. Slater & Sons, Inc., dated October 1, 1940, recorded October 29, 1940 in Deed Volume 227 at Page 7. Lizzie Bright Dodson died testate March 8, 1962 and under terms of her will filed in apartment 787, file 21 in the Office of the Probate Court for Greenville County, devised her one-half interest in the subject real estate to her daughter, Lillie Catherine Dodson. Charles E. Dodson has died, leaving as his heirs his

children, all of whom will execute deeds to this property, together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)'s heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
