release unto W. N. LESLIE, INC., its successors and assigns forever:

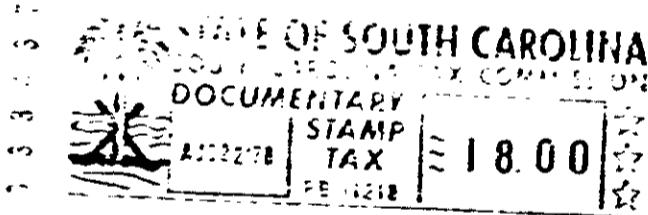
ALL that certain piece, parcel or lot of land located, lying and being in the County of

in the Greenville County R.M.C. Office in Plat Book 5-D at Page 98 and having, according to
said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the Eastern side of Brandywine Court at the joint front corner of
Lots 3 and 4 and running thence along the joint line of said lots, N. 82-26 E., 200.07 feet
to a point at the joint rear corner of Lots 3 and 4; thence, S. 07-25 E., 140 feet to a point
at the joint rear corner of Lots 4 and 5; thence, along the joint line of said lots, S. 85-
17 W., 179.0 feet to a point on a cul de sac; thence, with the curve of said cul de sac,
the radius of which is 50 feet, N. 44-33 W., 35.0 feet to a point; thence, continuing along
