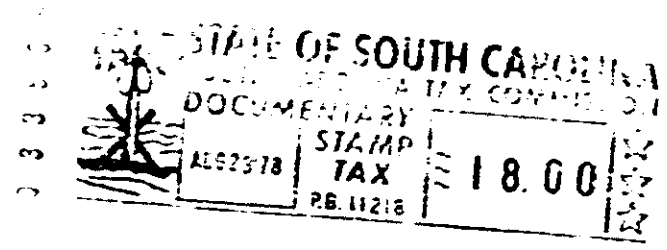
KNOW ALL MEN BY THESE PRESENTS, that Heritage Homes, Inc.
