KNOW ALL MEN BY THESE PRESENTS, That MULTIMEDIA, INC., a corporation chartered under the laws of the State of South Carolina, and having a principal place of business at Greenville, State of South Carolina, in consideration of Charitable Donation Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto THE GREENVILLE COUNTY FOUNDATION

ALL The following-described tracts or parcels of real estate situate, lying and being in the County of Greenville, State of South Carolina, and being more particularly described as follows:

(1) Tract, east side of North Main Street:

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, at the northeast intersection of North Main and East Washington Streets, in the City of Greenville, and having according to plat prepared by Dalton & Neves, July, 1926, the following metes and bounds, to-wit:

BEGINNING at the northeast corner of said Main and Washington Streets and running thence N. 20 E. 26.55 feet to the center of a brick wall; thence S. 70-10 E. 96 feet to the center of another brick wall; thence S. 20 W. 26.55 feet to Washington Street; thence N. 70-10 W. 96 feet to the beginning corner, together with one-half interest in the brick wall on the northern and eastern sides of the building situate on the lot herein described. Subject, however, to the right of the adjacent owners to use said brick walls and also ten-foot alley on the rear of lot herein described.

(2) Tract, east side of North Main Street:

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, and more particularly described as follows:

Situate on the east side of North Main Street, between East Washington and Coffee Streets, having a front on Main Street of twenty-five (25) feet, with a depth along parallel lines of eighty-five (85) feet to an alley in the rear, upon which there is a frontage of twenty-five (25) feet. Bounded on the north by the formerly H. C. Mark lot; on the east by an alley; on the south by the formerly Mrs. A. S. Duncan lot; on the west by Main Street.
