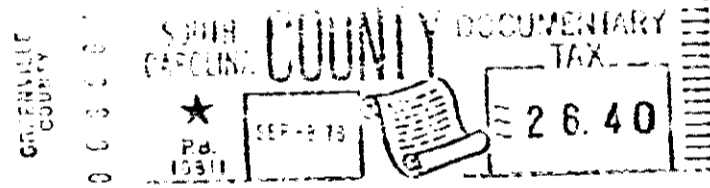
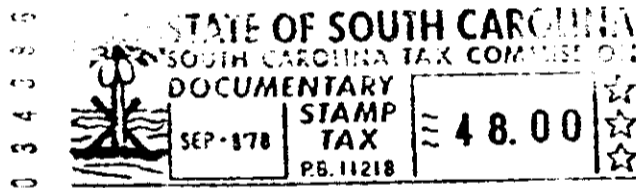
Fred W. Lister and Nancy S. Lister, their heirs and assigns forever:
