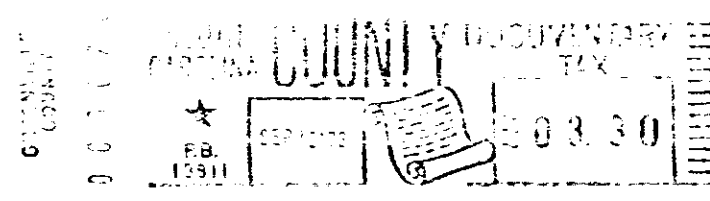
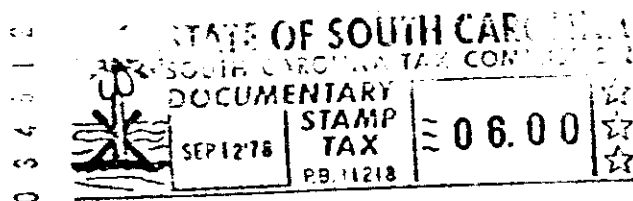

Lanford, Estate, dated March 20, 1975, revised August 11, 1978, prepared by Carl C.
