have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

JoStella R. Peden, her heirs and assigns forever, an undivided one-half ( $\frac{1}{2}$ ) interest in and to the following described property:

FIRST: All that certain parcel or tract of land located in the State and County aforesaid shown and delineated on plat entitled "Property of W. Scippio Peden", made by W. J. Riddle, Surveyor, dated January 12, 1938, and containing according to said plat 103.80 acres, this being the same property conveyed to the said W. Scippio Peden by deed of The Atlantic Joint Stock Land Bank of Raleigh dated April 1, 1936, and recorded on May 2, 1936, in Deed Book 185, page 20, RMC Office for Greenville County; LESS that certain tract of land containing .5 acres heretofore conveyed to Mildred R. Boyd by deed of W. S. Peden dated April 21, 1958, and recorded on July 24, 1958, in Deed Book 602, page 425, RMC Office for Greenville County; AND LESS that certain tract of land containing 7.07 acres heretofore conveyed to James R. Riddle, Surveyor, dated October 21, 1950, recorded in Plat Book N, page 141 B, RMC Office for Greenville County, and containing according to said plat, 29.20 acres, this being the same property conveyed to the said W. Scippio Peden by deed of C. M. Chapman dated November 1, 1950, and recorded on November 6, 1950, in Deed Book 422, page 468, RMC Office for Greenville County.

THIRD: All that certain parcel or tract of land located in the State and County aforesaid shown and delineated on plat entitled "Property of W. S. Peden", made by C. O.
