KNOW ALL MEN BY THESE PRESENTS, that G. D. CASE

in consideration of One (\$1.00) and correction of Deed----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto GOLDEN STRIP ASSOCIATES, a general partnership, its successors and assigns;

ALL that certain piece, parcel or lot of land, situate, lying, and being in the Town of Fountain Inn, Greenville County, South Carolina, containing 1.7 acres more or less, and being shown as a portion of that property on a plat for C. D. Case, prepared by C. O. Riddle, R. L. S., and dated September, 1954, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point in the Northwestern edge of Case Street, joint corner of property now or formerly of Edwards and running thence in a Southwesterly direction along the Northwestern edge of Case Street as shown on said plat approximately 410 feet to an iron pin in the edge of Case Street, thence turning and running N. 38-49 W., 150 feet to an iron pin; thence turning and running N. 2-41 E., 85.6 feet to a concrete marker; thence turning and running N. 52-15 E., 344.8 feet to an iron pin; thence turning and running S. 40-00 E., 94.3 feet to an iron pin; thence S. 40-44 E., approximately 62 feet to a point in the Northwestern edge of Case Street, THE POINT OF BEGINNING.

This being a portion of the property heretofore conveyed to C. D. Case by deed of B. B. Smith, recorded in the R. M. C. Office for Greenville County, on March 29, 1946, in Deed Book 290, at Page 49.

This conveyance is made subject to any restrictions, reservations, zoning ordinances or easements which may appear of record, on the recorded plat, or on the premises.

The purpose of this deed is to correct the Grantee's name as recorded in deed from C. D. Case, in Deed Book 1082, at Page 41, on June 28, 1978.
