ALL that certain piece, parcel or tract of land, lying, being and situate in the County of Greenville, State of South Carolina, shown on a plat of property of Carlos D. Davis and Jo Ann E. Davis prepared by J. L. Montgomery, III, R.L.S. in March, 1977, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book 6 T, Page 81, and which plat show the following metes and bounds, to-wit:
