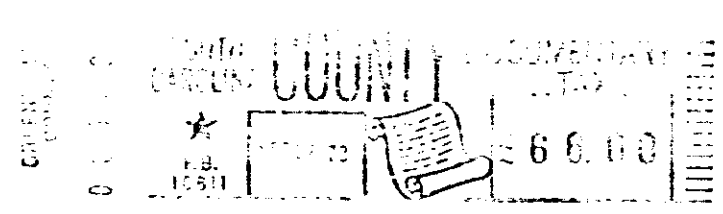
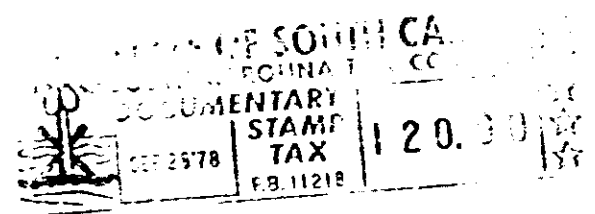
ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 23.7 acres, more or less, located on the northwest side of Garlington Road, and having, according to a survey of the property of T. Walter Brashier made on May 21, 1973, by Jones Engineering Service, the following metes and bounds, to-wit:

BEGINNING at an iron spike in the center of Garlington Road at a point approximately 685 feet in a northeastern direction from the intersection of Dublin Road with Garlington Road, and running thence N. 60-00 W. 205 feet to an iron pin; thence S. 50-29 W. 315 feet to an iron pin; thence N59-29 W. 172.3 feet to an iron pin; thence N. 30-42 E. 346 feet to an iron pin; thence N61-22 E. 73.4 feet to an iron pin; thence N. 18-26 E. 211.3 feet to an iron pin; thence N. 62-10 W. 535.3 feet to an iron pin; thence N. 0-07 W. 382 feet to an iron pin; thence S. 88-27 E. 1289.5 feet to an iron pin on or near a branch; thence along and with said branch, the following courses and distances: S. 13-36 W. 111.1 feet; S. 26-30 E. 93 feet; S. 45-18 E. 60 feet; S. 6-54 W. 190.8 feet; S. 21-06 W. 90 feet; and S. 29-45 W. 63 feet to the center of Garlington Road; and thence along and with the center of Garlington Road the following courses and distances: S. 50-40 W. 165 feet; S. 48-40 W. 300 feet; and S. 50-22 W. 300 feet to the point and place of beginning.
