and having its principal place of business at

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto REAL ESTATE

FUND INVESTMENT TRUST, its successors and assigns;

ALL that certain piece, parcel or tract of land, situate, lying and being in the County of Greenville, State of South Carolina and being on the northeastern side of Rosewood Circle in the southwestern side of U.S. Highway 276 and containing approximately 9.89 acres more or less and being shown and designated as Lots A, B, C and D on a Plat of Property of Mauldin Plaza, Inc. dated November 6, 1969, by Carolina Engineering and Surveying Company, recorded in the R.M.C. Office for Greenville County in Plat Book 4-C, at Page 143; and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin in the southwestern edge of U.S. Highway 276 and running thence S. 45-43 W. 505.6 feet to an iron pin; thence turning and running N. 60-37 W. 187.6 feet to an iron pin; thence N. 60-37 W. 213.2 feet to an iron pin; thence N. 55-17 W. 251.9 feet to an iron pin in the northeastern edge of Rosewood Circle; thence along said Circle N. 19-35 E. 204.8 feet to an iron pin; thence N. 10-41 E. 101.9 feet to an iron pin; thence N. 9-30 E. 123.8 feet to an iron pin, joint corner with property now or formerly of Dallas W. Griffin; thence along joint line with Griffin S. 44-17 E. 168 feet to an iron pin; thence continuing along line with Griffin N. 45-43 E. 300 feet to an iron pin in the southwestern edge of U.S. Highway 276; thence along said Highway S. 44-17 E. 583 feet to an iron pin; thence S. 44-17 E. 100 feet to an iron pin, the point of beginning.
