KNOW ALL MEN BY THESE PRESENTS, that I, Pearl J. Wood

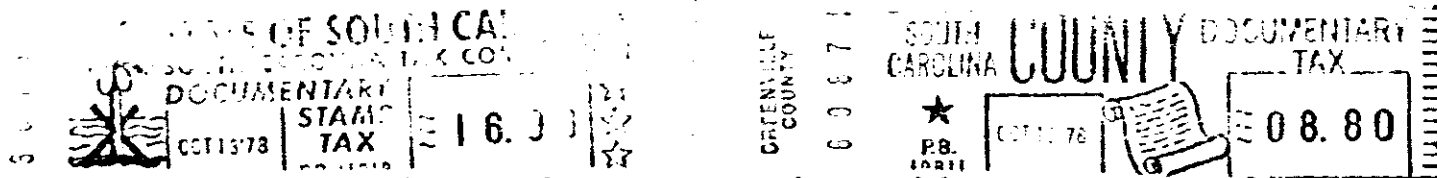
in consideration of Eight Thousand and No/100 (\$8,000.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Sam Raiden, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with the building and improvements thereon, in Greenville Township, Greenville County, State of South Carolina, lying and being on the easterly side of McAdoo Avenue in the City of Greenville, South Carolina, being shown as Lot No. 65 on the plat of Glen Grove Park as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book F, at Page 233, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the Easterly side of McAdoo Avenue at a point 370.1 feet Southwest of the Southeasterly corner of the intersection of McAdoo Avenue and Laurens Road, said pin also being the joint front corner of Lots 64 and 65 and running thence along the joint line of said lots S 74-12 E 150 feet to an iron pin, joint rear corner of Lots Nos. 50, 51, 64, and 65; thence along the joint line with Lot No. 50 S 15-48 W 50 feet to an iron pin, joint rear corner of Lots Nos. 49, 50, 65, and 66; thence along the joint line with Lot No. 66 N 74-12 W 150 feet to an iron pin on the Easterly side of McAdoo Avenue; thence along the Easterly side of McAdoo Avenue N 15-48 E 50 feet to the point of beginning.
