the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto James L. Julian, his heirs and assigns forever:

ALL that certain piece, parcel or tract of land with improvements thereon, lying, being and situate in the County of Greenville, State of South Carolina, fronting on Harrison Bridge Road and containing 6.1 acres in accordance with plat made by H. C. Clarkson dated October 3, 1978 and being more fully described in accordance with said plat to-wit:

BEGINNING at an iron pin on the northern side of Harrison Bridge Road said pin being 641.5 feet from the intersection of Harrison Bridge Road and Fork Shoals Road, also joint corner with property of even date conveyed to Thurman R. Julian and running thence N. 20-37 W. 662.2 feet to an iron pin; thence N. 18-56 W. 228 feet to an iron pin; thence N. 69-49 E. 305.86 feet to an iron pin on western side of County Road; thence along County Road S. 18-30 E. 916 feet to an iron pin at intersection of County Road and Harrison Bridge Road; thence along Harrison Bridge Road S. 75-03 W. 280 feet to an iron pin being the point of beginning.

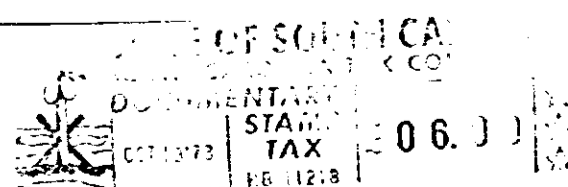
