in consideration of Fifty-four thousand (\$54,000.00) ----- Dollars,

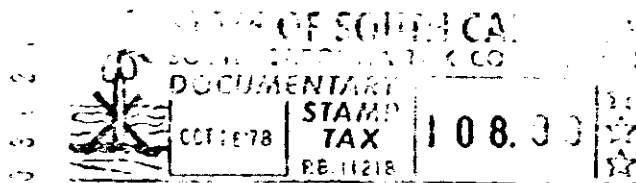

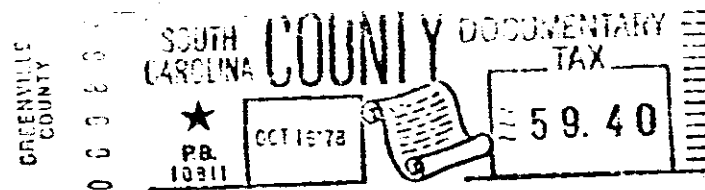
