ALL that certain piece, parcel or tract of land in the State of South Carolina, County of Greenville, near Travelers Rest, being shown as 3.4 acres on plat entitle "Property of D. H. Shetley, Jr.," prepared by W. R. Williams, Jr., surveyor, dated October 7, 1975, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the east side of (Northridge Road) thence N. 50-58 W., 102.8 feet to an iron pin; thence N. 42-15 W., 151.7 feet to an iron pin; thence N. 32-36 W., 67.8 feet to an iron pin; thence leaving the Road N. 68-46 E., 616.4 feet to an iron pin; thence joining the Allen property S. 24-23 E., 212 feet to an iron pin; thence S. 24-23 E., 212 feet to an iron pin; thence S. 59-13 W. 516.4 feet to an iron pin at the side of Road being the point of beginning.

This is a portion of that property conveyed to the grantors by Deed of E. C. Vernon and R. H. Vernon, dated February 17, 1975 and recorded in the RMC Office for Greenville County in Deed Book 1014 at page 820 on February 20, 1976.

1. Dwelling must be set-back a minimum of 35 feet from edge of Street. (This amounts to 60 feet from centerline of Street)
 2. Only one single family residence allowed on this tract. Minimum house size 1,400 square feet living area.
 3. Single wide mobile home not allowed. Double wide allowed on permanent brick or block foundation, 24 inches minimum ground clearance at lowest point required. Minimum double wide trailer size 24' x 55'.
 4. Temporary single wide mobile home allowed during construction of house. This mobile home can only be set-up after foundation for permanent house is constructed. A maximum of 1 year is allowed for the temporary mobile home.
