in consideration of Thirty-Four Thousand and No/100 (\$34,000.00)----- Dollars,

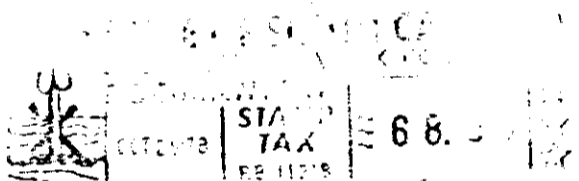

ALL that piece, parcel or lot of land, with the buildings and improvements thereon, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a portion of Lot No. 31, Section C, Stone Land Company, a plat of which is recorded in the RMC Office for Greenville County, S.C., in Plat Book A, Page 341, and having, according to a survey by Campbell and Clarkson, dated February 24, 1969, captioned "Property of Grady K.
