ALL water lines, mains, valves and appurtenances installed and located in, under or along Coventry Rd., County of Greenville, State of South Carolina, including approximately 430 feet, more or less, of 6" C. I. pipe; 240 feet, more or less, of 6" D. I. pipe; 460 feet, more or less, of 2" galvanized pipe; 2 - 6" valves to open right; 2 - 2" valves to open left; and 1 fire hydrant to be 3-way and open right, and is shown on a drawing entitled "Heritage Homes, Inc. to Commissioners of Public Works of the City of Greenville, S. C.", dated September 25, 1978, attached hereto and made a part of this conveyance.
