Know All Men by These Presents:

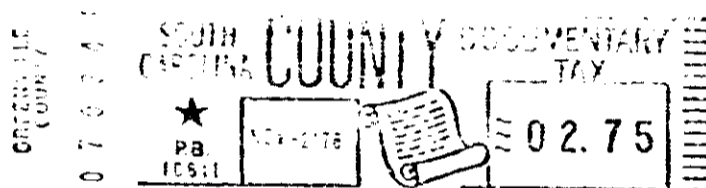

ALL that piece, parcel or lot of land in Oaklawn Township, Greenville County, State of South Carolina, in the Old Eastview School District, approximately two miles from Pelzer, South Carolina, and 1.5 miles southeast from State Highway S 23-52 and containing 2.68 acres, and having, according to a Plat made by Freeland & Associates, May 24, 1975, the following metes and bounds, to wit: 110 - 612.2 - 1 - 29.2

BEGINNING at an iron pin on the southerly side of an unnamed dirt road and running thence with the joint line of a 4.0 acre lot conveyed by the Grantors to Albert E. and Margaret C. Boone and shown on the referred to plat S. 13-05 E. 411 feet to a point in the center line of a branch; thence with the center line of the branch the traverse line of which is S. 79-36 E. 210 feet to a point in the center of said branch; thence leaving the branch and running N. 55-15 E. 250 feet to a point; thence N. 15-45 W. 55 feet to a point in the center of unnamed road; thence with the center of said unnamed road N. 65-45 W. 150 feet to an iron pin in the center of said unnamed dirt road; thence continuing on said old road N. 62-45 W. 401 feet to an iron pin in the center of the road, the point of beginning.
